Report on Forum activities

Welcome to the 2018 Forum Annual Report. This report covers the calendar year from January to December 2018, in line with Forum's financial year.

During this period, Forum held its Annual General Meeting of Forum members and associates (hereafter members) in Montréal, Canada on 30 October 2018. Forum also held

its annual conference for international volunteer cooperation organisations (IVCO) in Montréal.

Oxfam-Québec, Solidarité Union Cooperation (SUCO)

and Forum jointly hosted the IVCO conference, which focused on **Women** and youth: bridging the gap — volunteering for inclusive development.

The conference provided an opportunity for heads of volunteer organisations and delegates from public,

private, academic and NGO organisations from around the world to network, discuss pertinent issues in volunteering, share innovative approaches and strengthen alliances.

<u>Unité</u> hosted a meeting of European agencies involved in international volunteering and volunteering for

development. Held in Lucerne, Switzerland, in May 2018, attendees exchanged ideas and information on trends in European-based international volunteering

and volunteering for development, ethics, good practices and working towards adopting global standards.

Other achievements include the strategic involvement in the 2030 Agenda for Sustainable Development/ Sustainable Development Goals (SDGs) dialogue by the Forum Board of Directors, the Volunteer Groups Alliance (VGA) and Forum members. The VGA's side event to the

High-level Political Forum (HLPF) 2018 was significant in this space. The event, **The thread that binds - a global conversation on volunteerism and community resilience,** showcased voices and perspectives from some of the one billion volunteers who help strengthen local communities

around the world. It also launched the 2018 State of the World's Volunteerism Report and led a conversation between Member States, volunteers and development partners on how best to empower communities to help deliver the SDGs.

Interrelated with this, Forum's IVCO 2018 Papers series explored *Inclusive development for women and youth:* where are we at? The series looked in depth at inclusive development practice and policy for women and youth.

Member States and the HLPF have a key role in creating an enabling environment to ensure that we make the most of volunteering effort.

The Forum Leading Standards Working Group (Forum LSWG) continued its efforts in developing the Forum Global Standard for Volunteering for Development (Forum Standard) to complement the Forum Charter. The Charter outlines the principles, values and ethical behaviour underpinning international volunteering for sustainable development.

Work in this area builds on the Forum Board's consultation process with members (initiated in 2016) around strengthening the positioning of volunteering for development in the global context and the research and consultation phase (2018). The latter phase included a global survey bringing in 488 responses from 66 countries,

a desk review, a consultative session at IVCO 2018, and consultative workshops that brought together 144 people in nine countries. They represented organisations at a national level responsible for hosting and receiving volunteers.

Leadership of Forum's LSWG was formalised in October 2018 with Co-Chairs Mark Cumming (Head, Comhlámh and Forum Board member) and Stephen Goodman (Chief Executive Officer, Volunteer Service Abroad (VSA) and Forum Board member) taking this project forward.

Forum acknowledges everyone involved in strengthening the recognition of volunteerism's integral role in achieving the SDGs through these initiatives. A special thank you to VSO for their significant support of the creation of the Forum Standard to be drafted in 2019.



Activities

In 2018 Forum undertook the following activities in accordance with the strategic objectives laid out in the 2016-2020 Forum Strategic Plan.

Promoting effective knowledge generation and sharing amongst members

Sharing amongst members: IVCO 2018

In late October 2018 more than 220 representatives of international volunteer cooperation organisations and volunteer involving organisations from 29 countries gathered in Montréal for Forum's annual IVCO, exploring the theme Women and youth: bridging the gap — Volunteering for inclusive development. Participants represented diverse sectors including government, civil society, UN bodies, academia, the private sector and volunteers. They shared the common objective of ensuring inclusive development through policy, practice and volunteering for development.

The event spanned three days of lively discussions, in-depth workshops, inspiring talks and an innovative 'human library session' showcasing 39 stories from 'human books'.

Forum would like to acknowledge Oxfam-Québec and Solidarité Union Cooperation (SUCO) for their exceptional work in hosting IVCO 2018 and bringing a new dimension to the annual event.

Effective knowledge generation

Work in this area was accomplished by the Forum Research, Practice, Policy and Learning Group (Forum RPPL Group), led by Co-Chairs Paul Bird, Chief Executive Officer of AVI and Forum Board member, and Odette McCarthy, Uniterra Program Director – a World University Service of Canada-Centre for International Studies and Cooperation (WUSC-CECI) program and Forum Board member. The group coordinated Forum's series of IVCO 2018 papers and began planning the Forum basic measurement project survey to capture its collective contribution of volunteering for development. This is a key project supported by Forum. Measuring impact is a strategic priority for Forum and a key theme of the *Plan of Action to Integrate Volunteering into the 2030 Agenda (Plan of Action 2016–2030)*.

The inaugural Forum basic measurement project survey aims to collect data that will focus primarily on measuring what members do and how they operate (e.g. how many volunteers are supported and where they are based) with

some consideration of outcomes. Over the coming years, measurement data will increase in complexity to address the collective impact of volunteering for development/SDGs.

A one-day meeting of the Forum RPPL Group and invited guests took place immediately following IVCO 2018 on 1 November. Against the backdrop of the conference theme and within the broader context of Forum's strategic objectives, the day led to much valuable sharing and learning among academics and practitioners and helped to broaden the group's reach. Equally, it provided a strong foundation for the 2018–2019 Forum RPPL Group Action Plan, including the IVCO 2019 papers, the progression of the basic measurement project survey and work in support of the Plan of Action 2016–2030 and Global Technical Meeting 2020 (GTM2020).

Forum's effort in promoting effective knowledge generation and sharing amongst members was again enhanced by the striking design and communications work of Kate Vereshaka, coupled with the high standard set by proofreaders, Ellie Chowns and Kate Wragge.

Increasing visibility and recognition of the impact of volunteerism in development

Forum is at the forefront of researching, recognising and promoting volunteering for development as effective and sustainable development, including gaining recognition for volunteering for development in the 2030 Agenda and the SDGs.

The 2030 Agenda is our roadmap and its goals and targets are tools to get there.

In 2018 the VGA and (now former) VGA Coordinator, Wesley Moe, worked tirelessly throughout the year in the strategic positioning of volunteering for development at the global, regional and national levels. The VGA did much of this work through its formal role as Volunteer

Groups stakeholder at the UN. In these processes, the VGA promoted the contribution of volunteers to enhance their effectiveness by advocating for wider adoption of volunteer models with proven results, and to gain recognition for the crucial role of volunteers in monitoring and ultimately achieving the SDGs. The VGA lobbied individual governments, promoted good practices and shared innovations. The VGA supported volunteers themselves – particularly from the Global South – to ensure their voices were represented.

One highlight was the submission of a Volunteer Groups' Sectoral Position Paper to the HLPF 2018 on the theme *Transformation towards sustainable and resilient societies*. Forum members were encouraged to use the paper as a resource in their own efforts to ensure that volunteers and volunteer efforts are understood as essential to the successful implementation of the Agenda and attainment of the SDGs.

While recognising everyone who contributed to the VGA (detailed in Appendix One), the Forum Board particularly acknowledges the VGA Co-Chairs, Helge Espe (Norec) and Coline Peyre (France Volontaires), who strategically led the group in January-September 2018, followed by Mei Cobb (United Way Worldwide (UWW)) and Philip Goodwin (VSO) in October-December 2018.

Building a vibrant and inclusive constituency in support of international volunteering and volunteering for development

Volunteers and volunteer effort are essential to the successful attainment of the SDGs. The aim of eradicating poverty and promoting prosperity and planet will not be realised without the contributions of millions of properly supported and enabled volunteers and volunteer-driven organisations in both developing and developed countries.

In 2018, Forum's membership was made up of 24 members and four associate members. A special and warm welcome is extended to our newest member, HORIZONT3000.

Combined, the Forum network now represents 143 organisations² working across 124 countries.

Strengthening and focusing the capacity of Forum

Organisational capability and capacity to support and serve members is vital to Forum. Forum is resourced by membership subscriptions, occasional grants, voluntary staff time and funds from the respective organisations of the Chair and Forum Board of Directors. Subscriptions from members enable Forum to operate at a basic level with a part-time Executive Coordinator and capacity to organise the annual IVCO conference in partnership with a Forum member.


